**We are relaxed at Sandy Gulls & want you to enjoy your stay from start to finish but we do have a few guidelines.**

**Payment terms and conditions for all bookings**

- We strongly recommend guests make sure they have holiday insurance to cover any cancellation, as we do not offer a refund in all circumstances. You may find that you have holiday insurance as part of your home insurance or as a benefit of your bank account, for example.
- If we are not able to honour your booking for circumstances within our control, then we will offer you alternative dates or a full refund.
- If we are not able to honour your booking for circumstances beyond our control or yours, eg weather conditions, then it will be our choice whether to offer you a selection of alternative dates or a full refund.

**Payment terms and conditions for touring pitches**

- A £10 non-returnable deposit is required for all bookings.
- The remaining balance for a touring pitch is due on arrival, not departure. Payment is to be made to Christine (our Touring Park Manager) or at the site office in cash, cheque, bacs or card.
- Bookings for touring pitches are a minimum of 2 nights.

### **Cancellation terms for all bookings**

- We will treat a booking as cancelled if you tell us to do so, or if you do not arrive by 11pm on the first day of your booking.

### **Special terms and conditions for touring pitches**

- **Arrivals are from 12.00pm until 8.00pm and departures by 11.30am (unless prior arrangement)**
- The price is inclusive of TV/Electric Hook up, use of showers and toilet facilities, Awning and max 2 Adults.
- You were allocated your pitch at time of booking.
- There is now a barrier which has number plate recognition. If we have your correct vehicle registration the barrier will open automatically, however there is a 4-digit pin code attached to your booking document. This will open the barrier and the Toilet / Shower doors also and this code is exclusive to your booking.
- **We are Adults only and are unable to accept visitors with children on our touring park.**
- There are no extra charges for dogs (on the park on a lead) the beach below us is dog friendly all year round.
- Please go to your allocated pitch and Christine our touring park manager will come and see you to take full payment.
- We have no objection to you having visitors as long as they park sensibly and include no children. (If staying overnight a charge of £6 per person will be made)
- Our Touring Park is situated on a Cliff Top, which allows uninterrupted sea views - not all pitches are completely level, and you are advised to bring chocks to level your motorhome/caravan, or we can provide blocks.
- We do not allow Tents or Gazebo's (trailer tents are fine)
- Please use breathable groundsheets only.
- **WIFI** - WIFI is available through PayPal when you are here, or we can give you a voucher at the office or through Christine. You can pay via bacs and we can text you a code. This will be payable by cash or card, (Social distancing will be in place for this)
- Prices - 1 day – £2, 4 Days - £4.50, 1 Week £9
- **TV Cables** - We sell 10m TV cables at £10 each available from Christine.
- **Gas Sales** - We sell 6kg Gas bottles for £28.50 but must have an empty Calor bottle for exchange (please visit the office 9am-12noon for collection.)
- **Water point** - All water points have hand sanitizer readily available, please use. They will also be cleaned regularly by staff.

### **Terms and conditions for all bookings**

#### **Groups**

No groups of more than four people are accepted unless you are all members of the same family or all couples.

#### **Behaviour**

- No ball games are to be played anywhere on site.
- You should use our property safely and should not cause danger to others.

- You should obey all health and safety notices.
- You should act on the reasonable instructions of the staff.

### **Safety**

- You are responsible for the safety of your party.
- You are solely responsible for securing your property.
- Your caravan or accommodation may not be used for sleeping a number of persons greater than the number stipulated in your booking.
- You must ensure that all members of your party are familiar with the location of the Fire Points and the contents of any Fire Notices.
- You must not store fuels or combustible materials.
- You must make sure that any electrical equipment you bring is in good condition and safe to use at our property.
- **Beach Access** is along the maintained cliff top path or Vale Road **not** through the Touring Park (access to the path maybe gained by the gate in the bottom right corner of the touring Park or through the kissing gate, near caravan number 1). Please do not climb banks or cut through the Touring Park.
- **Cliff Path:** This has been severely eroded and under no circumstances are fresh paths or short cuts to be made. Playing on the cliff face, digging, sliding or damaging it in any way is forbidden as there is a danger of further cliff collapse or subsidence, which could result in serious injury or death. Any person damaging the cliff face will be asked to leave the Park. We encourage all site users to take the tarmac road at the North end of the Park to access the beach

### **Visitors**

- Any visitors must leave by 11pm.
- It is your responsibility to ensure that your visitors and all members of your party obey the rules.

### **Being a good neighbour**

- Please respect the privacy of others and keep noise to a minimum, with absolute quiet between 11pm and 7am
- You must keep away from any vacant pitches.
- You may only consume alcoholic drinks within the boundaries of your pitch.
- You must not use fire extinguishers for any improper purpose.
- You must not use a drone, powered model aircraft or any other powered flying object.
- You must not use any Chinese lanterns, fireworks or similar.
- You may not ride bicycles, scooters (or similar) so as to cause a nuisance or undue noise.

### **Respecting the environment**

- You are responsible for keeping your caravan or accommodation and the area around it clean and tidy.
- If you experience any problem with the electrical, gas or water system, you should contact us. You must not attempt to work on any part of the electrical, gas or water system yourself; this includes any installations.
- You must not introduce any foreign items into the drainage system including cleaning cloths, babies' nappies, sanitary towels, condoms, cooking fat, engine oil, grease or paint.
- You must not erect any tents which do not form part of your booking.
- You must not dig any hole.
- You may only use washing lines of the rotary type or the window sill type and must remove them and store them out of sight immediately after use.
- You must site washing lines to avoid inconvenience to others.

- You must use the refuse bins and recycling points provided.

### **Vehicles**

- You must insure all vehicles for use on the public road.
- You must insure all accessories and items towed by vehicles (such as towed boats and jet skis) as for use on the public road.
- Motor vehicle repairs must not be carried out but a recognised breakdown service may attend in the event of a breakdown.
- Quad bikes, trials bikes and powered scooters are not permitted.
- Drive all vehicles carefully and within any displayed speed limit.
- Hold a full current driving licence to drive any vehicle on our property.
- Please do not park anywhere except in the permitted parking spaces.
- Other than for delivering goods and services, you must not park or allow parking of commercial vehicles of any sort other by prior arrangement. This is because they are not suited to all parts of our property.

### **Animals**

- You must keep any dog on a lead at all times.
- You must clean up if your animal defecates.
- You are responsible for the good behaviour of your pets.
- Your pets should not be left on their own.

### **Post**

- You may only use our address for postal deliveries.

### **Emergencies**

We will try to leave you in peace to enjoy your stay. However, if there is an emergency or if we need to carry out urgent work or if we are concerned there has been a serious breach of these rules then we may need to enter your accommodation. We will give you as much notice as is reasonable in the circumstances.

### **Ejection for breach of these rules**

- In the event of persistent or serious breach of these rules by you or any member of your party, we may require the individual or the party to leave immediately.
- We will give you one chance if the breach can be put right. No refunds, no second chances.
